Anti -Ragging Policy

Ragging is a serious issue that can have long lasting effects on students. The University Grant Commission of India has implemented regulations to curb ragging in higher educational institutions. Our institution takes Anti Ragging measures to ensure a safe and healthy environment for students.

Rules and Regulations

- It is clearly mentioned in the college prospectus that ragging, in any form, is completely prohibited in the institution, and anyone found guilty of ragging is liable to be punished as per norms.
- Notices and warning regarding ragging are put up at various places in the campus.
- An undertaking form is filled by the students in regard of the prohibition of ragging.
- Anti Ragging and Grievance Cell conduct a meeting at the beginning of the college academic session for prevention of ragging in campus.
- Anti Ragging and Grievance Cell under the supervision of Principal, organizes Anti-Ragging campaigns inside the institute through banners, activities and lectures.
- Anti Ragging committee stays active in academic block, canteen, playground etc to prevent any kind of ragging. This team interacts with the senior and junior students to control ragging in college campus.

The Institution has a transparent mechanism for timely redressal of student grievances including sexual harassment and ragging cases.

S. D. Kanya Mahavidyala Mansa has constituted Grievance Redressed Cell against harassment and ragging, following the guidelines of University Grant Commission and is committed to provide a congenial and conducive environment.



Special Invitee

The meeting commenced with a welcome note by Joint Secretary (HE), Ministry of Education. JS (HE) addressed the members about the importance, constitution and mandate of the committee i.e. the main attention of the Committee shall be to focus on the evils of ragging, the modalities how these can be prevented and what stern action can be taken against the persons indulging in ragging. It shall also be suggested as to what action can be taken against the educational institutions where such ragging takes place and the authorities of such institutions. It shall be open to the Committee to appoint such persons, as deemed proper, to effectively deliberate on the measures to prevent anti ragging activities at the outset. Best practices of the States may also be shared with the Committee. These practices after consideration may be disseminated to other States/HEIs.

JS(HE) requested all the members to give suggestion as to how to implement effective measure against the people who are involved in ragging and requested Chairman of the committee to deliberate upon agenda points to discuss that how committee can suggest effective measures to stop ragging activities.

On behalf of UGC, Secretary, UGC welcomed Chairman of the committee and all other members of the committee. He informed the committee that UGC is playing a key role to implement of anti-ragging regulation to curb the menace of ragging in higher educational institutions. UGC is taking all initiatives by way of guiding all universities about how to create an atmosphere where student can interact in harmonious manner so that we can minimize the incidents of ragging. Secretary, UGC informed the committee that UGC sends advisory time to time to all higher educational institutions for curbing the menace of ragging. He also informed the committee that UGC has

developed a 24x7 anti ragging helpline, an anti-ragging call centre, a mobile application, along with monitoring agency and with the help of these UGC tries to resolve the matters of ragging to maximum possible extent in a time bound manner. Now with the able guidance of this committee, we shall be able to move further in creating better environment for students in our educational institutions and creating better measures so that the ragging incidents can be prevented.

JS (ARC), requested committee to move on to discuss the agenda items one by one:

Confirmation of Minutes of the 18th meeting of the Committee for monitoring measures to prevent ragging in higher educational institutions held on 08.06.2016.

The minutes were confirmed.

Action Taken on the last meeting of the Dr. R.K. Raghavan Committee held on 08.06.2016 and preventive measures taken by the Regulatory Authorities.

The Action Taken was noted.

Presentation was given by Prof Raj Kachroo about the monitoring mechanism of Ragging cases.

Submission by Dr. Sarvesh Tandon, Professor, Forensic Science, Safdarjung Hospital:

Dr. Tandon insisted that Higher Educational Institution need more support at higher authorities' level. Good amount of awareness should be created at institutional level, more counselling's are required. Call received for complaint should be checked, fake complaints call should be avoided. He asked Prof. Kachroo what is the criteria to check whether case is mild or severe.

Submission by Dr. Manoj Khanna, Principal, Ramjas College, New Delhi

Dr. Manoj Khanna enquired about the reason behind the cases pending from long time. He suggested to constitute an ICC like committee in all higher educational institutions for ragging also. He stressed the need to sensitize students at school level. There should be regular workshop for ragging similar to ICC for sexual harassment. Cases in some states like UP are very high, that needs to be looked carefully and should try to reduce these cases.

Submission by Sh. V. Chandar, Sannidhi Street, Tamil Nadu

The reported cases on ragging in the southern universities have come down substantially in the last decade, thanks to the severe measures adopted by all the authorities after quite a few ragging related murders in the previous periods. Same is the case in a few other states also.

The full details of such best practices which have given proven results have now to be shared to the needy States like UP and Bihar where more cases of ragging are still being reported. The scope of this committee needs to be widened from mere anti ragging (which has a limited connotation) to make it a widely encompassing positive body that can address the urgent needs of the behavioural enhancement qualities of youth. Youth related social issues such as over leasing, youth disobedience and indiscipline, crime against women, campus unrest etc. have to be viewed in a holistic view for surmounting with a clarity on their fundamental root causes. There is dire need to closely observe and monitor the psychological and mental makeup of the youth in their formative early teen age itself. As proactive and preventive measure, school syllabuses need to be widened broadly from the class tenth onwards and Behavioural Enhancement Counselling Sessions need to be provided to them to groom their mental make-up in the positive directions. The identified black sheeps in each class have to be given closer correctional attentions. Educational syllabus for teachers need to be revised to include enriched contents that enable and empower them for boosting their behavioural counselling skills for motivation, concentration, empathy, respect, care and concern for fellow students especially of the other gender etc. A sub-committee can be created to dwell deep into each of the above points and give more specific practical guidelines to the government for future implementation.

Submission by Sh. K.L Prasad, IPS (Retd), Mumbai

Awareness should be created at School level (9th, 10th standard). It will give a behavioural change from the beginning. There should be debates, tv shows, activities at school level.

Submission by JS (HE)

JS (HE) suggested to have Information Education Communication (IEC) Kit, E-content on abatement of ragging. There should be training programmes in the form of refresher, orientation courses, training of faculty, student awareness programmes and sensitization drives in educational institutions. She stressed for more support and counselling system required for capacity building of the faculty and sensitization of the students as well. Besides penal provisions may be mentioned specifically for ragging activities in the IEC literature. The following Initiatives/actions may also be taken:-

- (i) Sharing of best practices by States.
- (ii) Inviting UGC/AICTE and other Regulatory bodies as special invitees whenever required.
- (iii) Data of FIRs registered to review the status of severe cases.
- (iv) The Regulations/Guidelines, IEC material and best practices of Department of Higher Education in respect of anti-ragging activities may also be shared with Department of School Education & Literacy for awareness purposes.
- (v) For effective implementation of anti-ragging provisions, Regulatory bodies may be requested to monitor the compliance of points as per the checklist meant for HEIs.

Submission by the Chairman of the committee

Chairman appreciated the role of UGC has been playing in abatement of Ragging programme. He stressed

- a. Monitoring mechanism needs to be strengthened so that a swift and transparent redressal mechanism is there.
- b. Timely disposal of pending cases and states having more than 100 cases should be sensitized about quality disposal of cases.
- c. Verification mechanism should be there to understand whether the complaint has been dealt properly or not.

The Committee desired that the Anti-ragging Monitoring Agency should identify the institutions which were lagging behind in Anti-ragging and share the same with regulatory bodies. The Committee desired that this may be done early. Prof. Kachroo mentioned that the Agency was frequently sending mails to all concerned on Anti-ragging and also using social media for Anti-ragging.

The meeting ended with a vote of thanks to the Chair.



Subject: Revised procedure for students to file online Anti Ragging Affidavit.

Dear Madam/Sir,

As you are aware, in pursuance to the Judgment of the Hon'ble Supreme Court of India dated 8.5.2009 in Civil Appeal No. 887/2009, the UGC notified "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" and in compliance of the 2nd Amendment in UGC Regulations, it is compulsory for each student and his/her parent/Guardian to submit an online undertaking each academic year at either of the two designated web sites, namely, www.antiragging.in and www.amanmovement.org.

As part of UGC's initiative towards reduction of compliance burden of its stakeholders, UGC has revised the procedure for students to file online Anti Ragging Affidavit.

The revised procedure is as follows:

Step 1: A student will submit his/her details on the same web sites (www.antiragging.in and www.amanmovement.org) as before; read and confirm that he/she and his/her parents/Guardians have read and understood the regulations on curbing the menace of ragging. He/She will confirm & agree that he/she will not engage in ragging in any form. (Step 1 is the same like before).

Step 2: The student will receive an E MAIL with his/her registration number and a web link. The student will forward the link to the E mail of the Nodal officer in his/her university/college. (Please note that the student will not receive pdf affidavits and he/she is not required to print & sign it as used to be the case earlier).

Step 3: The Nodal Officer in the university/college can click on the link of any forwarded e mails that he/she will receive from any student of his/her college to get the list of those students who have submitted Anti Ragging Affidavits/Undertakings in his/her college. The list will be updated every 24 hours.

जैसा कि आप जानते हैं, सिविल अपील संख्या 887/2009 में भारत के माननीय सर्वोच्च न्यायालय के दिनांक 8.5.2009 के निर्णय के अनुसरण में, विश्वविद्यालय अनुदान आयोग ने "उच्चतर शिक्षण संस्थानों में रैगिंग को रोकने के लिए विनियम, 2009" में अधिसूचित किया है जिसके दूसरे संशोधन के अनुपालन में, प्रत्येक विद्यार्थी और उनके माता-पिता/अभिभावक को प्रत्येक शैक्षणिक वर्ष में www.antiragging.in और www.amanmovement.org में से किसी एक वेबसाइट पर ऑनलाइन वचन पत्र जमा करवाना अनिवार्य है।

इस प्रक्रिया को सहज करते हुए विश्वविद्यालय अनुदान आयोग ने विद्यार्थियों के लिए ऑनलाइन रैगिंग रोधी शपथ-पत्र दाखिल करने की प्रक्रिया में संशोधन किया है।

संशोधित प्रक्रिया निम्नवत है:

- चरण 1: विद्यार्थी अपना विवरण पूर्ववत् (www.antiragging.in और www.amanmovement.org) वेबसाइट पर जमा करेंगे और पढ़कर इसकी पुष्टि करेंगे कि वे और उनके माता-पिता/अभिभावकों ने रैगिंग को रोकने के लिए विनियम को अच्छी तरह पढ़ और समझ लिया है, वे इस बात की भी पुष्टि करेंगे कि वे किसी भी रूप में रैगिंग में शामिल नहीं होंगे। (चरण 1 पहले जैसा ही है)।
- चरण 2: विद्यार्थी को उसकी पंजीकरण संख्या और एक वेब लिंक के लिए एक ई-मेल प्राप्त होगा। विद्यार्थी अपने विश्वविद्यालय/महाविद्यालय में नोडल अधिकारी के ई-मेल पर लिंक अग्रेषित करेंगे। (कृपया ध्यान दें कि विद्यार्थी को पीडीएफ शपथ-पत्र प्राप्त नहीं होगा और उसे इसे प्रिंट करने और हस्ताक्षर करने की आवश्यकता नहीं है जैसा कि पहले हुआ करता था)।

As you are aware, UGC has framed "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" in order to prohibit, prevent and eliminate the scourge of ragging from universities, deemed universities and other higher educational institutions in the country. These regulations are available on the UGC website (www.ugc.ac.in).

The regulations provide for various monitoring mechanisms to ensure its compliance. One such mechanism is monitoring through an Anti-Ragging Committee, which in its 19th meeting, has emphasized the following points:

1. Sharing of best practices by States to UGC.
2. Data of FIR registered to review the status of severe cases.
3. The Regulations/Guidelines, Information Education Communication (IEC) material and best practices of Department of Higher Education in respect of anti-ragging activities to be shared with Department of School Education & Literacy for awareness purposes.
4. Sensitization of the States for timely disposal of pending cases.

In light of the above, I request you to kindly intervene in the matter and advise all Higher Education Institutions under your purview to take suitable action on the above mentioned points and also for compliance of the Regulations to make India ragging free.

(Student's Grievances and Anti-Ragging)


Our institute has constituted Grievance Redressal Cell against harassment and ragging. This cell addresses the grievances and complaints registered by the students.

- A lecture was organised to create awareness among students about Anti- Ragging on September 8, 2018. Ms. Jagmohini Gauba discussed the acts which would lead to ragging, impacts of ragging on the junior classes and legal actions against such acts.
- A lecture was organised by Anti- Ragging Cell on August 5, 2021 to make students aware about the Anti-Ragging activities. Dr. Jyoti Bala was Keynote speaker. 210 students were present there and remained quite vigilant.
- The Anti- Ragging Cell organised a lecture on August 17, 2022 to sensitize the students regarding Anti-Ragging. Dr Payal Sabharwal was Keynote speaker. 275 students attended the lecture and pledged to avoid indulging into ragging activities.
- A meeting of the Grievance Redressal Cell was held on August 30, 2018 regarding the complaint of Jaspreet kaur, a student of M.A. The matter was regarding the theft of a book. The committee discussed the matter and solved it.
- The Grievance Redressal Cell held a meeting on March 13, 2019 to cater to the problem of misconduct faced by a student of B.A. III named Preeti Sharma by her classmates. The matter was discussed and students were counselled to follow the code of conduct.
- A meeting of Grievance Redressal Cell was held on September 30, 2021 regarding the theft of money of Sukhwinder kaur, a student of PGDCA. The matter was discussed and solved.
- A meeting of Grievance Redressal Cell was held on November 5, 2022 regarding the problem of van faced by Lakshmi Devi, a student of B.A. III student. The matter was discussed and the issue was resolved.
